Harm reduction efforts are saving lives but drug toxicity continues at record high levels affecting First Nations families and communities across BC.

The data presented here is specific to the Northern Region.

Toxic Drug Poisoning Deaths Of First Nations People

There is no change from the same period in 2023.

Rate of Toxic Drug Poisoning Death

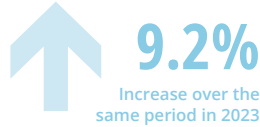

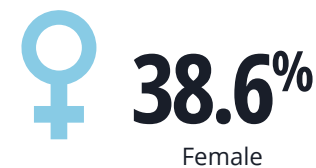
This is an increase of 9.2% from 346 events experienced during the same period in 2023.

First Nations people experienced an event rate 7.5x higher than other residents of the region between Jan-June 2024.

Events of First Nations People BY SEX



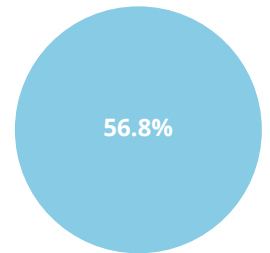
Events of First Nations People BY AGE



First Nations People are Disproportionately Represented in Toxic Drug Poisoning Events



First Nations people make up 14.8% of the region's population.



56.8% of toxic drug poisoning events between Jan-June 2024 were First Nations people.

NOTES

- Most toxic drug poisoning events are non-fatal and represent instances where paramedics were called and responded to a poisoning. Events that were treated successfully in community and events where 9-1-1 was not called are not captured in this data
- Event data is only collected for people with documented BC Personal Health Numbers (PHNs), and is therefore likely an underestimate, due to missing PHNs for some events
